## Practice Profile

---

Gordon has developed an extensive practice across several different areas of law. In the Legal 500 he is ranked as a leading junior in Commercial Litigation, Personal Injury and Medical Negligence & Professional Negligence (where he has been described as being "truly of senior counsel quality and ability"). In Chambers and Partners he is ranked in the field of Personal Injury where he is described as being "just exceptional".

He is primarily instructed to act on behalf of insurance clients in a wide variety of disputes. He has substantial experience in property damage cases, many involving complex claims of high value. He is regularly instructed in professional negligence actions including construction disputes (both litigation and adjudication); claims against solicitors and surveyors; and medical negligence cases. In the field of personal injury he is particularly skilled in the quantification of damages and has given several seminars on the application of the Ogden Tables and on Periodical Payment Orders. He has extensive experience in high value claims arising out of catastrophic injury (both spinal and brain injury); fatal accidents; and industrial disease.

He has expertise in actions involving the European Convention on Human Rights. He appeared on behalf of the Scottish Ministers before a full bench of the Inner House in *Hamilton v Ferguson Transport (Spean Bridge) Limited*. He identified and developed a novel argument concerning Convention rights in the context of an adjudication which found favour with the court in *Whyte & Mackay Limited v Blyth & Blyth Consulting Engineers Limited*. He has appeared as junior counsel in both the Privy Council and the Supreme Court in leading cases such as *Cadder v HMA*, *McInnes v HMA* and *McDonald v HMA*.

Gordon is instructed in contractual disputes and property disputes (including commercial leasing). He also has experience in the field of regulatory crime where he has acted in high profile cases including *Balmer v HMA* and *HMA v Transco plc*.

He was instructed by Dame Elish Angiolini QC to act as junior counsel to the investigation into practices at Mortonhall Crematorium regarding the disposal of ashes following the cremation of

babies.

He was appointed as Standing Junior Counsel to the Scottish Government between 2008 and 2011. He is presently appointed as Standing Junior Counsel to the Ministry of Defence. He has acted as a devilmaster and is an instructor on the devils' training course.
