Practice Profile

Jonathan has extensive, evidentiary and appellate advocacy experience in the Court of Session, High Court and Supreme Court as well as various Tribunals and Inquiries. His areas of practice cover and have covered personal injuries, professional negligence, public and administrative law, planning and conservation, crime (including regulatory, financial and health and safety). He offers a breadth of experience of both subject matter and forum.

As junior counsel, Jonathan had a varied practice covering personal injuries work, professional negligence, public and administrative law and planning and heritage law. He served as a standing junior counsel for ten years: first to the Secretary of State for Scotland and then to the Department of Work and Pensions. This work saw regular judicial review, specialist tribunal and appellate appearances.

Jonathan entered Crown Office, at the same time as taking silk in 2009, where he became a senior advocate deputy. Appointments included time in the National Sexual Crimes Unit and as dedicated Crown Counsel to the Health and Safety Executive. Work involved: extensive trial work, including white collar and regulatory crime; regular advisory work; regular appearance in the Appeal Court; appearance in the Supreme Court and written interventions in the Supreme Court

He has appeared in a number of FAs and public inquiries: recently representing family interests in the Clutha helicopter crash inquiry, and an educational establishment in the Child Abuse Inquiry.

Most recently, practice, in the Outer and Inner House of the Court of Session has seen a focus on personal injuries cases involving catastrophic injuries, industrial disease litigation, child abuse litigation & medical negligence.

Jonathan served for eight years as Director of the Arnot Manderson Stable. He has served as as Vice Convenor of the Church of Scotland Disciplinary Committee. He is passionately committed to advocacy training; is a regular instructor on the Faculty's Devil's Training, teaches on the Law Society's Solicitor Advocates Training Programme; and has on several occasions been an instructor

on the South African Bar's advocacy training programmes, both in residential courses in South Africa and online. Jonathan is Convenor of the Faculty's Training and Education Committee.

Jonathan was appointed Procurator to the General Assembly of the Church of Scotland in May 2023, a role that may be seen as standing senior counsel to the Church.
