# **Practice Profile**

Laura has a busy and varied civil practice, with particular emphasis on personal injury and professional negligence claims, inquiries, and professional discipline.

Laura is regularly instructed in fatal and catastrophic cases, and in actions that have as their subject matter deaths in state custody, employers' liability, harassment, industrial disease, sexual abuse and suicide.

Laura is Lead Junior Counsel to the Sheku Bayoh Public Inquiry. The Inquiry was set up to establish the circumstances of Mr Bayoh's death following restraint by the police; to examine the post-incident management process and investigations that followed; and to determine whether Mr Bayoh's race was a relevant factor. She is also a Standing Junior Counsel to the Scottish Government.

Laura has represented clients at fitness to practice panels (NMC; ARB).

From 2009-2012, Laura held the office of Advocate Depute. In this role, she prosecuted (as Lead Counsel) many high-profile, difficult and anxious cases before the High Court of Justiciary. These included murder, culpable homicide, armed robbery, causing death by dangerous driving, rape, and the sexual abuse of children.

Laura's appointment as an Advocate Depute followed a long and successful career in the Crown Office, during which time she held a number of specialised legal posts, including the investigation of sudden, suspicious and unexpected deaths and the conduct of Fatal Accident Inquiries; precognoscing and indicting cases for trial in the High Court; and international co-operation in the investigation and prosecution of crime.

Laura's criminal experience informs her approach to her civil work, and she brings to her practice considerable advocacy experience, sound judgement, and a meticulous approach to case preparation. In both the civil and criminal courts, Laura has extensive experience of preparing and presenting cases which are both factually and legally complex, and in which expert evidence has been led.

Alongside her civil practice, Laura maintains an interest in criminal law. She takes the evidence of vulnerable witnesses on Commission in advance of trial, on behalf of the Crown. As defence counsel, she has been instructed in murder and rape cases, and as Lead Counsel for one of 5 accused in a 14 week High Court trial arising out of allegations of historical sexual and physical abuse in a residential home for vulnerable children run by the Christian Brothers.

Laura has a particular interest in cases at the interface between the criminal and civil law: she was instructed as Junior Counsel to represent a professional footballer in a civil action of damages for rape, both at proof in the Court of Session and in the subsequent reclaiming motion, and has been instructed to pursue civil actions for damages in a number of historical sexual abuse cases since the coming into force of the Limitation (Childhood Abuse)(Scotland) Act 2017.

### HMA v Mohammed Akram, 2012

Accused convicted of sexual assault of a 4 year old girl, whose evidence was taken on commission by live link.

### • HMA v Ruraidh Docherty, 2011

Accused convicted of causing death by dangerous driving; both accused and deceased were school boys.

### • HMA v John Nugent, 2011

Accused convicted of historical sexual abuse of three children.

# • HMA v Kevin Kirkpatrick, 2011

Rape - one of the first cases to be brought under the Sexual Offences (Scotland) Act 2009.

### HMA v Robert Clark, 2011

Accused convicted of historical physical and sexual abuse of two children.

Accused convicted of the attempted murder of his wife of 40 years. Defence of sleepwalking. The only eye witness was the complainer who was supportive of her husband and convinced he was asleep. Complex expert evidence led.

### • HMA v Alan Stewart, 2010

Accused convicted of causing death by careless driving.

# • HMA v Gary Gallacher, 2010

Accused convicted of armed robbery.

### • HMA v Robert Black, 2010

Accused convicted of two charges of assault with intent to rape.

### • HMA v James Whitson, 2010

Accused convicted of culpable homicide after supplying methadone to a vulnerable teenage girl, in the knowledge that she would use the methadone to overdose to commit suicide.

### • HMA v Gerard Costa, 2010

Accused convicted of assault with intent to rape.

Selected cases from Laura's time as a Procurator Fiscal Depute/Principal Depute:

### • HMA v Marek Harcar, 2009

Laura assisted the then Lord Advocate, Dame Elish Angiolini, with the international aspects of this murder prosecution; this involved traveling to Slovakia to oversee the ingathering of evidence and questioning of witnesses there.

### HMA v ICL Plastics and ICL Tech, 2007

This prosecution, brought under health and safety legislation, followed a factory explosion in which a number of people lost their lives. Laura's role was to draft the charges and indict the case for trial. The accused companies pled guilty and significant fines were imposed.

During her time as a Procurator Fiscal Depute, Laura prosecuted several Sheriff Court cases
arising from road traffic fatalities - including the prosecution of a police officer who collided with
another vehicle during a police chase. She conducted a number of prosecutions in which evidence
was taken from child witnesses. Laura prosecuted two high-profile cases brought under health and
safety legislation, following fatal accidents in hotel premises. She conducted a number of Fatal
Accident Inquiries, including deaths in custody, deaths in the workplace and a complex medical
FAI arising out of a misdiagnosis.

## **Publications & Seminars**

Laura collaborated with a crime writer, forensic scientist, pathologist and professional colleagues to stage a reconstruction of a 1930s murder trial at the Bloody Scotland crime writing festival (2019). All performances sold out and the production received high acclaim, with articles in several newspapers. The production was filmed by the Modern Studies Association, to be used as part of the school curriculum throughout Scotland. The film was shown as the closing event at the Bloody Scotland 2020 (online) Festival and was followed by a panel discussion, which Laura chaired. She had previously chaired an event at Bloody Scotland in 2017, in which she debated the need for accuracy in the way in which courtroom scenes are portrayed in works of fiction with 3 lawyers-turned-crime-writers.

Laura has written about her passion for legal education in both the Herald and the Scotsman. She provides occasional advice to crime writers and television script writers on criminal law, evidence and procedure. She is an advocacy trainer and mentor.

During the course of her career, Laura has developed an interest in, and commitment to, helping vulnerable witnesses give their best evidence. She has given a number of presentations on this topic (including a talk on special measures for vulnerable witnesses at a Law Society conference, and a talk to members of the French Judiciary in Paris, organised by the Judicial Studies Committee). She contributed to the Faculty response to the draft Vulnerable Witnesses Bill.

During her time in Crown Office, Laura spoke at numerous seminars on a range of topics, and was interviewed by the BBC for a radio broadcast on the role of the Fiscal in the investigation of sudden deaths. She contributed to the training of A&E doctors on the same subject

Laura served on an Advisory Group to the Scottish Law Commission during the preparation of its Discussion Paper on Damages for Personal Injury (2022).
